## BEECHWOOD CO-OPERATIVE HOMES INC. - PET POLICY: By-law 4 - Schedule A: Occupancy Agreement; Schedule L: Pets:

Ownership of a household pet is a privilege not a right. This privilege, once given, may be withdrawn for cause by vote of the Board of Directors. Pet owners who fail to bring appropriate attention and diligence to the care of their pets can cause aggravation to other members and interfere with the quiet enjoyment of their homes.

The following rules apply to all members who own household pets:

1. Since there is a limit to the number of dogs and cats that can be easily accommodated in the Co-op, members will not keep more than two such animals as household pets.
2. Members shall not keep vicious animals. Disputes concerning these determinations will be settled by the Board of Directors on a case by case basis.
3. The Board will consider request to keep exotic pets on a case by case basis, taking into account the member's ability to provide humane and appropriate housing.
4. Pet owners must not permit their pets to create a nuisance, noise or odor inside or outside their residence that will cause a disturbance to any other member
5. No animals may be permitted to roam free.
6. Pet owners are expected to clean up or repair damage after their pets immediately after any mess is created or damage done. Patios and garages are not to be used as pet toilet facilities. All cat owners must provide indoor facilities for their cats.
7. All pets must be leashed. Even when on a leash, dogs may not be left unattended outside a unit for more than two hours.
8. All pets are to be restricted within the unit boundaries, except when accompanied to be exercised. Unit boundaries are defined as the area at the back of the unit between the privacy fences, and at the front extending from the normal outside dimensions of the unit to the roadway.
9. The K-W Humane Society is authorized to enforce the City of Waterloo by-laws with regards to pets. Members will be notified annually of these by-laws and any changes. In any cases where the co-op's by-laws or policies are more restrictive than the City of Waterloo, the Humane Society will not enforce.
10. Subject to appeal to the Board, all cats must be spayed or neutered. Members are encouraged to spay or neuter dogs.
11. Certificates of vaccination and if applicable, proof of spaying/neutering are to be submitted annually to the co-op office.
12. Any charges incurred by the co-op to capture, surrender or rescue any pet will be charged back to the member household.
